### Objectives and investment policy

The investment objective of the Fund is to provide long-term (5 – 10 years) growth through a combination of capital and income, with an emphasis on capital.

The Fund will adopt a global investment approach, unconstrained by a formal benchmark, with a diversified exposure to a range of asset classes including equities (both UK and global); government and public securities, investment grade corporate bonds (corporate loans that pay interest), deposits, cash and near cash (to provide liquidity), alternative assets and other fixed interest investments.

The Fund will invest primarily (at least 70%) in collective investment vehicles (for example open ended investment companies, unit trusts, exchange traded products, investment trusts). Typically at least 75% will be exposed to equities, with the standard weighting being 75%-90%.

Through these investments, the Fund may also obtain indirect exposure to alternative assets, including property, infrastructure, private equity and gold. The Fund may also invest directly in the asset classes listed above with the exception of alternative assets.

Derivatives may be used to reduce risk or cost or to generate additional capital or income at proportionate risk (efficient portfolio management).

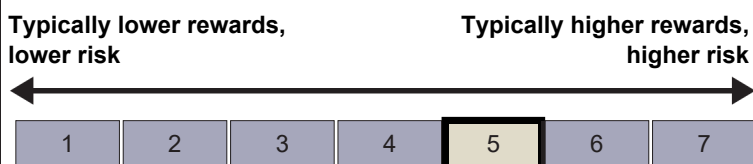
Investors can redeem shares on demand, at the daily valuation point of 12 noon (UK time) when this is a normal business day in the UK.

For income shares, any income received is paid out to you twice a year. For accumulation shares, any income received is reflected in the price of shares.

Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money in the short-term (within 5 years). The Fund should be viewed as a long-term investment only.

### Risk and reward profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The shaded area in the table below shows the Fund's ranking on the Risk and Reward Indicator.



- As the Fund launched on 1 August 2019, the indicator has been calculated based in part on the volatility of the Investment Association Mixed Investment 40-85% Shares Sector (GBP) average over the last five years (in total return and GBP terms).
- The Fund is in the above risk category because it invests in a variety of asset classes.
- The lowest category does not mean a Fund is a risk free investment.

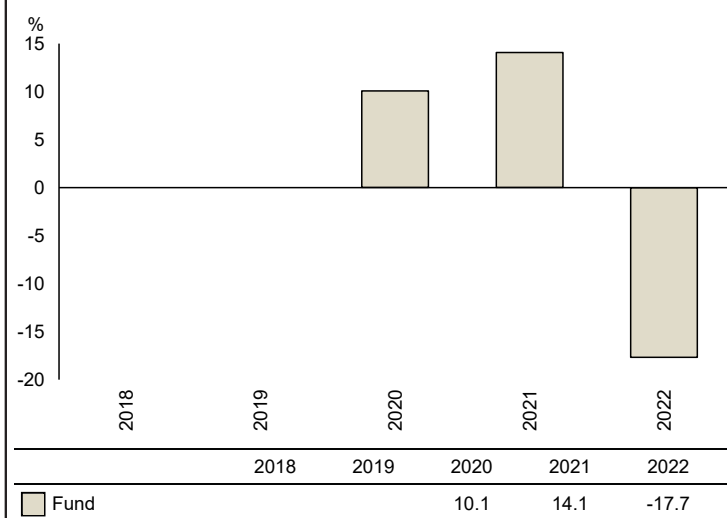
